MEMORANDUM: To Members of the National Committee to Abolish the Un-American Activities Committee and local Council leaders

In view of the serious leadership problems created by Frank Wilkinson's imprisonment and Aubrey Williams' illness, there is grave danger that the work of the National Committee will lose its momentum and sense of planning unless imprediate steps are taken to strengthen its coordination and collective work.

I am therefore taking the liberty of proposing a number of concrete organizational steps and some immediate work projects which must receive consideration before further time is lost. These proposals are the product of exchanges of views and discussions with leaders of the Abolition movement from coast to coast. The suggestion that I undertake the responsibility of initially projecting these questions in the role of a coordinator came from the initiative of the Citizens Committee to Preserve American Freedoms in Los Angeles and is made with the agreement of the two functioning National Officers, Robert Kenny, Treasurer and Dorothy Marshall, Secretary.

The special need for defining organizational and policy-making procedure and responsibility arises in part from the past informal structure of the NCAUAC, which depended to such a large extent upon the personal leadership of Frank Wilkinson and Aubrey Williams.

## I. ORGANIZATIONAL STRUCTURE:

1. The officers and members of the National Committee are as follows (National Committee memorandum dated August 15, 1960):

3. A coordinating committee pro tem shall be established in Chicago, consisting of William T. Baird, Richard Criley and a third member to be designated by the Chicago Committee DBR This coordinating committee shall be responsible for the coordination of work projects, the organization of exchange of opinion, and the polling of the opinions of National Committee members. It will work under the direction of the functioning national officers.

#### II. IMEDIATE NATIONAL PROJECTS:

- A. National Speaking Tour. It is proposed that Burton White, past chairman of the Bay Area Student Committee to Abolish HUAC, undertake a national speaking tour of about two months duration. He was one of the leaders and initiators of the anti-HUAC movement in the Bay Area and played a part in the San Francisco demonstrations; he has appeared on radio and television and in many meetings and debates on the West Coast. While it is suggested that he be free to speak under the auspices of numerous organizations, both student and non-student, it is proposed that the National Committee undertake to coordinate the tour and provide financial assistance.
- 1. Finances: Funds (designated by the donor for such purposes) are available to the NC to pay Burton White a salary of \$250.00 per month while he is on tour, and to advance initial funds for air fare. It is proposed that travel costs be assessed proportionately to the areas visited, money being raised at local meetings for this purpose; surplus funds from meetings to be kept by local groups.

### 2. Objectives:

- a. To stimulate student efforts for abolition of the HUAC and to encourage the organization of student civil liberties groups.
- b. To help launch a national campaign directed to Comgress for the achievement of a maximum vote against HUAC appropriations in January 1962.
- c. To further the collection of signatures and other support for executive clemency for Carl Braden and Frank Wilkinson.
- d. To stimulate the "abolition" efforts of non-student civil liberties groups.
- 3. RESPONSIBILITIES FOR COORDINATION OF TOUR:

- 4. Time Schedule: Speaking dates from second week of October to mid-December.

  Midwest dates set for November 6 17.
- B. LITERATURE: (Many of these proposals are temative and subject to change and further suggestion. Where responsibility for preparation of literature is not indicated, the assignments are to be worked out from Chicago.)
- 1. Collections of Resolutions and Editorials. To be revised and brought up to date by the Los Angeles Committee; to be used for presentation to Congress as was done in 1961 and for other general uses.
- 2. <u>Irving Hall Article on the Meisenbach Casereprinted from The Californian.</u>
  15,000 copies of these are reported to be available from the Southern Farmer
  Press at 5.00 per M. Should we consider printing additional copies?
- 3. "Behind the Bars for the First Amendment" (revised and brought up to date).
  Bill Price and Harvey O'Connor have agreed to make nefessary revisions.
- 4. "My Beliefs and My Associations, etc." (on Braden case) is available from the Southern Conference Educational Fund, 822 Perdido Street, New Orleans 12, La.
- 5. Full Text of Braden and Wilkinson Dissents in pamphlet form.

Question: Should the majority opinion also be included in an alternate edition?

- 6. Text of the Ad-Hoc Clemency Petition for Carl Braden and Frank Wilkinson with partial list of signers (perhaps in similar form to reprinting of New York Post Abolition ad,) Note: The total listing of over 2,500 is too numerous to reprint.
- 7. Brochure on Mational Student Congress based upon text of civil liberties resolutions and Capital Times news stories.
- 8. A Basic low cost piece for quantity distribution on subject of 1962 HUAC appropriations. The Nation Magazine has granted permission for reprint of an article which may form part of such a piece.
- C. Preparations for second session of 87th Congress in January 1962.
