

The Meisenbach Case

Because of the immense significance of the acquittal of Robert Meisenbach, the Bay Area Student Committee has added two new pamphlets on the trial to its list of literature. Both of these items point up the significance of the trial to the House Committee on Un-American Activities propaganda film, *Operation Abolition, * and the report by J. Edgar Hoover, *Communist Target--Youth, on the San Francisco student demonstrations.



A REPRINT OF THE LEAD ARTICLE IN THE JUNE ISSUE OF THE CAL-FORNIAN MAGAZINE, THE MEISENBACH CASE: THE F.B. I. HUAC CONVICTED, " BY IRVING HALL. THIS ARTICLE PRESENTS IN DETAIL THE PROCEEDINGS OF THE TRIAL, THE NEW EVIDENCE IT BROUGHT TO LIGHT, ITS SIGNIFICANCE TO THE FILM, J. EDGAR HOOVER AND THE HOUSE COMMITTEE, AS WELL AS SUPPLEMENTAL IN-FORMATION ON THE HISTORY OF THE CASE AND THE "SUPPRESSED" POLICE REPORTS UPON WHICH THE HOUSE COMMITTEE AND HOOVER BASED THEIR REPORTS.
